## **NOTICE OF ACCEPTANCE OF LOW POWER FM BROADCAST APPLICATIONS AND NOTIFICATION OF PETITIONS TO DENY DEADLINE**

**Report No. LPFM-S-5**

**Released: September 6, 2002**

NOTICE is hereby given that the low power FM (LPFM) broadcast applications listed in the attached appendix are accepted for filing. The listed applications were properly filed during the fourth LPFM window (June 11-15, 2001) or earlier windows and are not in conflict with any other application filed during these windows.<sup>1</sup> Each of the applications also fully complies with LPFM station protection requirements. *See 47 C.F.R. § 73.807(a)(1).*<sup>2</sup>

Petitions to deny the applications listed in the attached appendix and minor amendments to the applications must be on file with the Commission not later than the close of business on October 7, 2002. Amendments filed pursuant to this notice must be classified as "minor" under the provisions of 47 C.F.R. § 73.871.

Groups of mutually exclusive applications that were properly filed during the windows and comply with Commission and statutory requirements will be announced by subsequent Public Notice.

<sup>1</sup> This list consists mainly of applications from the following jurisdictions: Alabama, Arkansas, Guam, Kentucky, Massachusetts, and Montana. The Commission initially intended to have a separate LPFM filing window for each of five groups of states and jurisdictions. *See Public Notice* entitled "FCC Announces Five-Stage Filing Window for Low Power FM Broadcast Station Applications," DA 00-621, released March 17, 2000. However, the June 2001 filing window permitted the filing of applications for two such groups of states and jurisdictions. The listed applications are from states and jurisdictions that were originally intended to be in the fifth filing window ("Group III" in the *Public Notice*). Applications from other states and jurisdictions that were permitted to be filed during the June 2001 window will be listed in subsequent public notices.

<sup>2</sup> A court decision recently held that a provision of the Radio Broadcasting Preservation Act and the Commission's implementing rule (47 C.F.R. § 73.854) regarding the ineligibility of former unlicensed broadcasters to receive an LPFM license are unconstitutional. *See Ruggiero v. FCC*, 278 F.3d 1323 (D.C. Cir. 2002). Although that decision subsequently has been vacated upon the court's grant of a petition for rehearing en banc filed by the United States and the Commission (see *Ruggiero v. FCC*, No. 00-1100 (D.C. Cir. May 2, 2002)), our determination here that the applications listed in this public notice are "acceptable" is in no case the result of the staff taking adverse action with respect to a conflicting LPFM application that failed to satisfy that Commission rule regarding unlicensed broadcasters. Therefore, the ultimate resolution of *Ruggiero* by the court will not affect this action.
