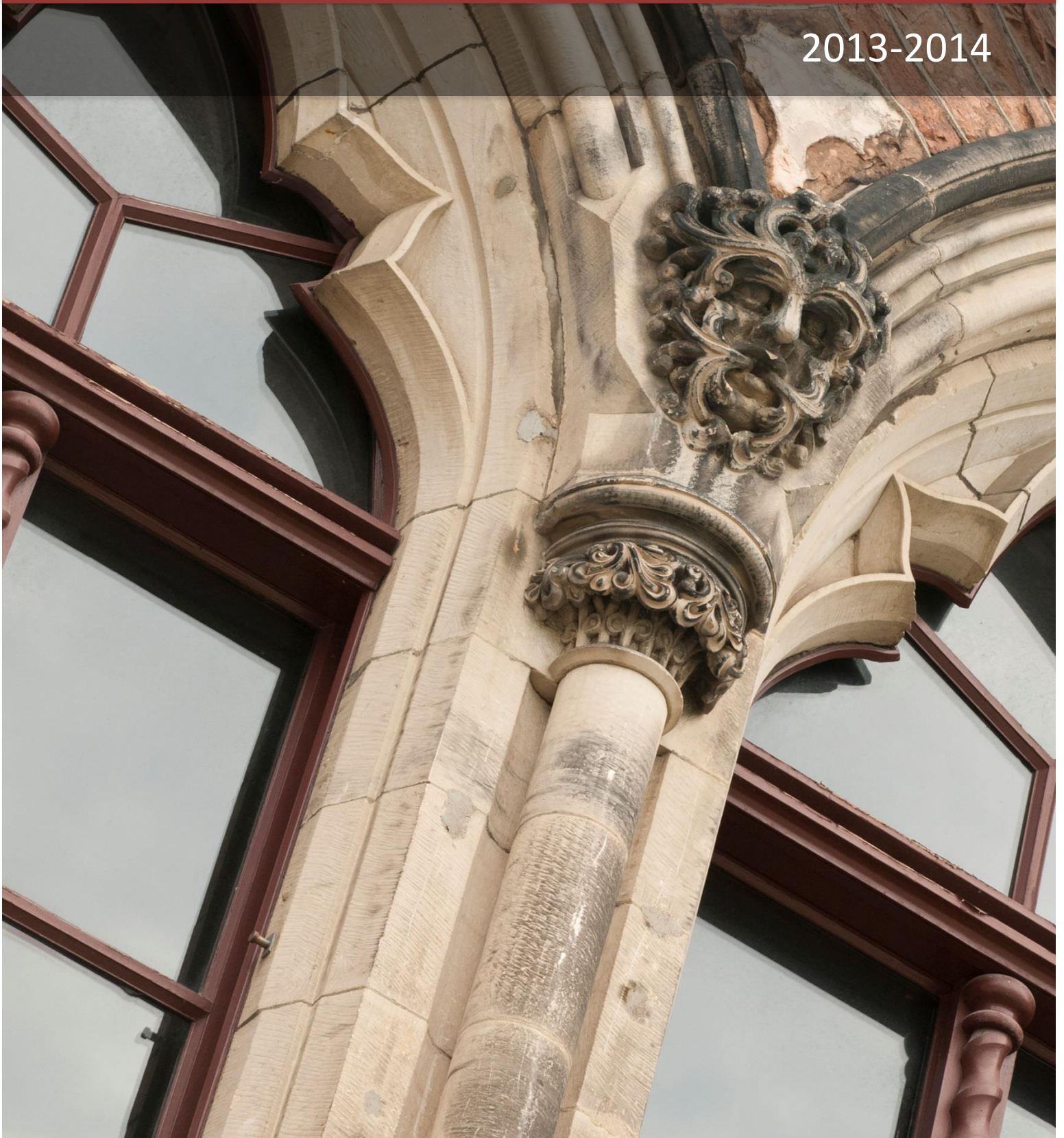

Message from the Principal Clerk of Committees



Committees are at the very heart of the work of the Senate, and every year well over a thousand Canadians contribute to their work by appearing as witnesses. Other Canadians follow the work of committees by watching the webcasts or CPAC broadcasts, or by reading the many committee documents, including transcripts of meetings, minutes and reports, on the parliamentary website. Senators spend an enormous amount of time in committee, and the Committees Directorate is very proud to provide the administrative and procedural support required to achieve committee objectives.

Activities levels in 2013-2014 reflect the hiatus in committee activity due to the prorogation of the First Session of the 41st Parliament on September 13, 2013. Prorogation (i.e., the end of a parliamentary session) ends committee activity, and committees must be reconstituted and organized at the beginning of each new session. The Second Session of the 41st Parliament opened on October 16, 2013 with a Speech from the Throne read in the Senate by the Governor General, His Excellency the Right Honourable David Johnston. Organization meetings, at which chairs and deputy chairs were elected and planning for the new session began, were held in early November. Committee work was well underway shortly thereafter, as committees picked up where they left off on many special studies, and as they launched new studies. As you will see from the summaries included in this annual report, a great deal of valuable work was completed in the course of 2013-2014.

Inter-sessional periods provide an opportunity for key public information Directorate documents to be updated (e.g., *Fundamentals of Senate Committees*, answers to *Frequently Asked Questions*), while also ensuring that other core tasks, such as archiving of committee documents, are completed. Work also continued intensively on Iris, a multi-year project to replace the legacy systems that underpin the work of the Senate. Iris will create a single coherent system for storing, tracking and sharing information about senators and the work they do in the Senate Chamber and in committees. In 2013-2014, the focus was on the development of the Committee Business Module, and we are looking forward to the launch of this module in October 2014.

I know that I speak for all directorate employees when I say we take great pride in supporting the important and valuable work done by Senate committees to contribute to public policy development and improve the lives of all Canadians.

Part I – General Information

Overview of Activities and Expenditures

Operating Expenditures*

During fiscal year 2013-2014, the Directorate provided administrative, procedural, informational and other support to Senate committees, which include:

- 16 standing committees (and 1 subcommittee)
- 2 standing joint committees (composed of members of the Senate and the House of Commons)
- the Committee of Selection

The size of committees, their general areas of study and the number of members required for quorum are set under rules 12-3, 12-6 and 12-7 of the *Rules of the Senate*.

Committee Activities

Committees account for much of the activity of the Senate. On average, over 50 bills are examined and 50 special studies are undertaken each year. While all committees must respect the *Rules of the Senate* and the *Senate Administrative Rules*, there are significant variations between committees with respect to how they undertake, organize and carry out their work. In addition, some committees focus almost exclusively on legislation, while others give special studies most of their attention.

Consultations

Every year, a number of trips are undertaken to gather testimony at the local and regional levels. Committees hold formal public hearings in locations throughout Canada, and undertake more informal fact-finding trips both within Canada and abroad. Committee travel provides senators with the opportunity to better familiarize themselves with the issues they are studying and to obtain evidence and information that cannot be obtained in Ottawa.

When committees travel outside Canada to inquire into matters, the meetings are called fact-finding missions, which means they are not considered official proceedings and no transcripts are published. The information gathered, however, is still valid to the committee's inquiry and can be used in a report of the committee.

Highlights of Special Study Reports

Standing Committee on Aboriginal Peoples

"The People Who Own Themselves": Recognition of Métis Identity in Canada

(Twelfth Report [interim] tabled in the Senate on June 6, 2013;
Sessional Paper No. 1/41-1655S)

The question of Métis identity is very complex and comprises historical, legal, political and cultural dimensions, and the study, in a broad sense, was about Canada's recognition of the Métis. It sought to ask, "How can the federal government recognize the Métis in a manner that fundamentally respects the ways in which the Métis view themselves?"

In addition to hearing witnesses in Ottawa for this study, the committee travelled to Manitoba, Saskatchewan, Alberta, British Columbia, and the Northwest Territories, for fact-finding missions.

The report made 3 recommendations:

- No. 1: That Aboriginal Affairs and Northern Development Canada (AANDC), in collaboration with relevant government departments and Métis organizations, develop and implement a strategy for gathering and analyzing demographic...information...to improve access to reliable...statistical information on Métis populations.
- No. 2: That AANDC...develop, in collaboration with Métis organizations and communities, a plan that will:
 - Build on the work...of existing researchers...to identify relevant historical documentation on the Métis...to make data readily accessible; and
 - Develop and propose an appropriately resourced research program to support...Métis...in gathering information on...their historic communities, including written documentation and oral histories.
- No. 3: That AANDC continue to support bilateral and tripartite negotiations with parties...with a view to developing a...comprehensive approach to relations between Canada and the Métis; and, in particular:
 - Renew its commitment to...discussions with parties...by clearly identifying...priority issues for discussion...and timelines for the achievement of these objectives;
 - Develop an action plan for engagement with...regional Métis groups with regard to their views on Métis identity and the bases on which they claim to represent Métis constituencies, and table a progress report on the action plan...by 1 June 2014.

Standing Committee on Banking, Trade and Commerce

The Registered Disability Savings Plan Program: Why Isn't It Helping More People?

(Third Report [final] tabled in the Senate on March 26, 2014;
Sessional Paper No. 2/41-394S)

Registered disability savings plans (RDSPs) were announced in the 2007 federal budget in response to recommendations by the Expert Panel on Financial Security for Children with Severe Disabilities. The objective of the RDSP program is to enable parents and others to save for the medium- and long-term financial security of a disabled individual. On average, about 12,000 RDSPs have been established each year since the RDSP program became effective in 2008. These 78,000 RDSPs represent an uptake rate of

15% among the approximately 500,000 disabled individuals in Canada who are eligible to establish a RDSP.

During its study, the committee examined various reasons for the low uptake rate in relation to the RDSP program, and made four recommendations on ways in which this rate might be increased. First, the committee recommended that the provinces and territories ensure that disabled adults can access the RDSP program, and that the federal government continue to work with the provinces and territories to improve access to the program. Second, the committee recommended that the federal government improve its communication efforts with respect to the RDSP program. Third, the committee recommended that the federal government lower the 10-year waiting period to 5 years, and reduce the amount to be repaid under the assistance holdback amount rules. Finally, the committee's witnesses identified administrative issues in relation to the RDSP program as a possible reason for the low uptake rate. The committee recommended that the federal government ensure that the needs of disabled individuals wishing to establish a RDSP are met, perhaps through the establishment of a federal initiative or the funding of federally-recognized organizations that could provide assistance. As well, the committee recommended that the government strongly consider the possibility of having a RDSP automatically established when someone qualifies for the Disability Tax Credit.

Standing Committee on Energy, the Environment and Natural Resources

Moving Energy Safely: A Study of the Safe Transport of Hydrocarbons by Pipelines, Tankers and Railcars in Canada

(Twelfth Report [final] deposited with the Clerk of the Senate on August 22, 2013;
Sessional Paper No. 1/41-1825S)

On November 28, 2012, the Standing Committee on Energy, the Environment and Natural Resources initiated a study of the safe transportation of bulk hydrocarbons by transmission pipelines, tankers and railcars in Canada. The goal was to examine the current state of emergency and spill prevention, preparedness and response frameworks under federal authority and to make recommendations to improve public safety and the protection of the environment.

Including rail transportation recommendations, the committee made a total of 13 recommendations. There are five recommendations related to marine spills. They include expanding spill data collection, modernizing spill preparedness and response capacities and providing responder immunity protection for marine response organizations that assist in non-ship source marine spills. There are two pipeline recommendations: first, that the National Energy Board develop a program to audit for safety culture; and second, that the federal government facilitate a national access point for information on buried utility infrastructure to prevent third party damage by excavators. There is one general recommendation to the National Energy Board and Transport Canada to provide information on transportation-related oil and gas spills in an accessible manner.

Standing Committee on Fisheries and Oceans

The Lobster Fishery: Staying on Course

(Tenth Report [final] tabled in the Senate on May 28, 2013;
Sessional Paper No. 1/41-1636S)

Lobster has been an important fishery in Canada for more than a century. Following the collapse of ground-fish stocks in the early 1990s, the lobster fishery became the most important source of income for thousands of harvesters. It remains an economic pillar for many coastal communities in the Atlantic provinces and Quebec. Lobster is Canada's most lucrative fishery, with landings valued at \$620 million in 2011. The exports of lobster and lobster products together generated over \$1 billion in 2012.

However, as of 2008, the lobster fishery was faced with challenges on a scale never seen in the past. The global economic downturn, combined with a strong Canadian dollar, resulted in a decline in the demand for lobster products and led to depressed landing prices. Many harvesters responded to declining shore prices and higher operational costs by intensifying their landings of lobster to maintain their revenues, thereby saturating the market. Structural problems inherent to the fishery were unmasked and highlighted the need for restructuring and rationalization. In response, the federal government put in place several programs to support harvesters severely harmed by the drop in market demand and to address longer term challenges. Given the economic conditions, there was a fear the lobster fishery would continue to struggle.

In this context, the Standing Committee on Fisheries and Oceans conducted a study on the lobster fishery in Atlantic Canada and Quebec. A total of eight public hearings took place in Ottawa and two full days of hearings were held in Moncton, New Brunswick. The committee heard from 50 witnesses, including officials from federal and provincial fisheries departments, harvesters, First Nations representatives, buyers and processors, as well as researchers.

The committee heard repeatedly that the lobster fishery is too important to rural and coastal communities and to the overall economy of the Atlantic provinces and Quebec to go forward without a clear vision, long term solutions, and adequate support. With support from federal and provincial governments, the entire lobster industry embarked on a set of initiatives to ensure its viability. The committee believed these initiatives were going in the right direction, but efforts needed to be sustained.

A set of findings and six recommendations were published by the committee in a report entitled *The Lobster Fishery: Staying on Course*, adopted by the Senate on May 30, 2013. The overarching objective of the recommendations was to ensure the lobster industry stays on course and continues to make changes to ensure future stability and sustainability.

Standing Committee on Foreign Affairs and International Trade

Building Bridges: Canada-Turkey Relations and Beyond
(Thirteenth Report [final] tabled in the Senate on June 20, 2013;
Sessional Paper No. 1/41-798S)

Building Bridges: Canada-Turkey Relations and Beyond*
(Second Report [final] tabled in the Senate on November 28, 2013;
Sessional Paper No. 2/41-236S)

The committee's report on the economic and political developments in the Republic of Turkey, their regional and global influences, and the implications for Canadian interests and opportunities made six recommendations to the Government of Canada by which to deepen political engagement and enhance commercial diplomacy. Notably, the committee recommended that the Government of Canada maintain consistent engagement with the Government of the Republic of Turkey at the highest political levels, identify Turkey as a strategic commercial priority, accelerate negotiations on a free trade agreement, and facilitate partnerships between Turkish and Canadian businesses, including in third countries. In particular, the report highlighted those Turkish sectors with the greatest potential for Canadian investors and businesses, including agriculture, mining, energy, infrastructure and transportation, as well as education. In defining the best that Canada has to offer and differentiating Canada from its competitors, the report emphasised the committee's strong belief that a "Canada Brand" would serve as an important strategy for Canada beyond the promotion of trade relations.

In this respect, education stands out as a key element of how Canada can brand itself and the Canadian advantage in the innovation and technology sectors. Accordingly, the committee recommended that the Government of Canada develop a foreign policy strategy that features a Canada Brand and profiles

Canada's advantages, notably in technology and education. It also recommended that the Government of Canada consider memoranda of understanding with the Government of the Republic of Turkey in the areas of science and technology, mining and energy. In light of Turkey's education and training priorities, the committee also recommended that the Government of Canada undertake to enter into a youth mobility agreement with the Government of the Republic of Turkey.

The committee's study and report were being finalized as demonstrations across Turkey were taking place, and the report highlighted Turkey's internal challenges and issues which must be addressed as the country continues its democratic and economic modernization. In the report's forward, the committee indicated its belief that the contents of the report remain an accurate assessment of the Canada-Turkey relationship.

Standing Committee on Human Rights

Canada's International and National Human Rights Obligations

(Thirteenth Report [interim] tabled in the Senate on June 25, 2013;
Sessional Paper No. 1/41-1727S)

In 2012, the committee held a meeting with respect to the review of Canada's human rights record as part of the Universal Periodic Review by the United Nations Human Rights Council. In early 2013, a further meeting addressed the Canadian review before the United Nations Committee on the Rights of the Child. The committee also held three meetings on the topic of United Nations Security Council Resolution 1325 and subsequent resolutions with respect to the women, peace and security agenda in 2012 and 2013. On June 25, 2013, the Standing Committee of Human Rights tabled a report regarding these three topics. The report recognized the Government of Canada's work on these files and encouraged increased engagement with civil society and provision of information to the public with respect to Canada's international human rights treaty obligations and reporting to UN bodies on such obligations. It also urged the government to publish an annual report with respect to implementation of Resolution 1325.

Employment Equity in the Federal Public Service: Staying Vigilant for Equality

(Second Report [interim] tabled in the Senate on December 10, 2013;
Sessional Paper No. 2/41- 273S)

As part of its ongoing study of employment equity in the public service since 2004, the committee held six meetings between October 2011 and May 2013 examining successes and challenges to date in ensuring equality for women, Aboriginal people, persons with disabilities and members of visible minority groups in the public service. Twenty-eight witnesses from government, public sector unions and academia testified before the committee. A report, *Employment Equity in the Federal Public Service: Staying Vigilant for Equality*, was tabled on December 10, 2013. The report included two recommendations, one outlining various means to improve monitoring and evaluation to achieve the goal of employment equity in the federal public service and the other encouraging the government to expand advocacy and employee participation on the topic.

Recognising Rights: Strengthening Off-Reserve First Nations Communities

(Third Report [interim] tabled in the Senate on December 12, 2013;
Sessional Paper No. 2/41- 286S)

After hearing from witnesses across the country (Ottawa, Winnipeg, Saskatoon and Vancouver), the committee tabled the report *Recognising Rights: Strengthening Off-Reserve First Nations Communities* on

December 12, 2013. The committee heard from 84 witnesses from government, academia and service delivery organizations, as well as individuals. The report outlines the testimony the committee heard and, in particular, focuses on currently available federal programs, the source and nature of rights of off-reserve First Nations people, off-reserve First Nations people's relationships with reserve communities, access to services, the role of friendship centres, and off-reserve First Nations women and girls. The report makes observations with respect to access to services for off-reserve First Nations people, the work of friendship centres in their provision of services, and the additional burdens of off-reserve First Nations women and girls.

Standing Committee on National Security and Defence

Conduct Becoming: Why the Royal Canadian Mounted Police must Transform its Culture

(Fourteenth Report [final] tabled in the Senate on June 18, 2013;
Sessional Paper No. 1/41-1715S)

Following a series of allegations of harassment within the Royal Canadian Mounted Police and lawsuits across the country, the committee received the mandate to examine the issue. Following the testimony of many witnesses and documents brought forward, the committee found that one of the most important issues facing the RCMP is trust. The committee made a series of recommendations to ensure that all RCMP members and employees are confident that the Force will strive to protect them and that the RCMP take immediate, meaningful steps to enhance the public's trust and bolster the members' trust in the disciplinary systems designed to protect them.

Standing Committee on Social Affairs, Science and Technology

In From the Margins, Part II: Reducing Barriers to Social Inclusion and Social Cohesion

(Twenty-Sixth Report [final] tabled in the Senate on June 18, 2013;
Sessional Paper No. 1/41- 1716S)

Building on the testimony provided in an earlier report – *In from the Margins – A Call to Action on Poverty, Housing and Homelessness*, the committee heard from more than 50 additional witnesses in its exploration of social inclusion in Canada. During this study, statistical evidence, testimony during hearings and written submissions identified particular groups that are vulnerable to economic and social marginalization, including recent immigrants, visible minorities, religious minorities, sexual minorities, urban Aboriginal peoples, and individuals with disabilities. Recommendations were made to support these groups in overcoming barriers, with a particular focus on income mobility as a route to greater equality and inclusion. The report, *In from the Margins, Part II: Reducing Barriers to Social Inclusion and Social Cohesion*, was tabled in the Senate on June 18, 2013.

Prescription Pharmaceuticals in Canada: Off-Label Use

(Fifth Report [interim] tabled in the Senate on January 30, 2014;
Sessional Paper No. 2/41-311S)

The third phase of the pharmaceutical study on off-label use was undertaken between February and April 2013, when the committee heard from 22 witnesses over the course of seven meetings. The report *Prescription Pharmaceuticals in Canada: Off-Label Use*, which was tabled in January 2014, included 18 recommendations. In part the report called for improved tracking of off-label drug use in order to assess safety and effectiveness by re-stating its recommendations from reports on phases one and two for implementation of electronic medical records, electronic health records and an electronic system for dispensed prescription pharmaceuticals. With respect to reporting adverse reactions associated with off-label use, the committee recommended facilitating access to the report form and that the forms require

that information about off-label use be included. The report also emphasizes the need for additional research on the safety and effectiveness of off-label drug uses, including in vulnerable populations, and that information obtained from this research be reflected in the drug label.

Standing Committee on Transport and Communications

One Size Doesn't Fit All: The Future Growth and Competitiveness of Canadian Air Travel

(Eighth Report [final] tabled in the Senate on April 17, 2013;
Sessional Paper No. 1/41-1553S)

In April 2013, the committee tabled its final report on the Canadian airline industry entitled *One Size Doesn't Fit All: The Future Growth and Competitiveness of Canadian Air Travel*. After hearing from 98 witnesses, the report, which contained seven recommendations, concluded that efforts to improve the competitiveness of regional and northern air transport should begin with transportation strategies that support air traffic growth, and infrastructure improvements that could lead to accessible pricing for all Canadians.

During its hearings, the committee heard that airports generate over \$45 billion in economic activity and airport operations provide over 200,000 jobs, resulting in significant tax revenues for all levels of government. Despite the industry's success, it faces serious challenges. The committee provides recommendations with the aim of enhancing competitiveness which includes a call for a single cohesive national air travel strategy, infrastructure improvements and the phase out of ground rents.

The report was warmly welcomed by the industry. According to the President of the Canadian Airports Council, Daniel-Robert Gooch, "The Senate's study of Canada's aviation sector – the first in more than a decade – has been one of the most comprehensive aviation studies undertaken in Canada. After two decades of tremendous change in our industry, a study of this nature is timely and the contents of this report will certainly flavour the nature of our ongoing discussions with government and industry partners."

Part II – Committee Profiles 2013-2014

Standing Committee on Aboriginal Peoples

A. General Information

In fiscal year 2013-2014, the committee received six orders of reference, including: one for a special study on the housing and infrastructure on reserves; three for legislation; and one to examine a government response to its report on Additions to Reserve. The committee also renewed a broad order of reference authorizing it to examine and report on the federal government's constitutional, treaty, political, and legal responsibilities to First Nations, Inuit and Métis peoples, and on other matters generally relating to the Aboriginal Peoples of Canada.

The committee spent the majority of its time carrying out work under its global order of reference on the federal government's constitutional, treaty, political, and legal responsibilities to First Nations, Inuit and Métis peoples. In fiscal year 2013-2014, the committee held 12 meetings and heard 38 witnesses in the course of this study. Three of these meetings involving nine witnesses were dedicated to briefings on the issue of housing on reserves.

Informed by these briefings, the committee decided to adopt a specific order of reference focusing on housing and infrastructure on reserves. By March 31, 2014, it had held 11 meetings and heard five witnesses. The study is ongoing, thus no report has been tabled.

In June 2013, the committee issued a report based on a special study on the Métis that it had conducted in the previous fiscal year. The report is entitled, *"The People Who Own Themselves": Recognition of Métis Identity in Canada*.

On the legislative front, the committee was tasked with studying Bill C-62, An Act to give effect to the Yale First Nation Final Agreement and to make consequential amendments to other Acts. The committee held one meeting and heard five witnesses on this subject. The committee reported the matter on June 13, 2013 without amendment.

During its consideration of Bill C-9, An Act respecting the election and term of office of chiefs and councillors of certain First Nations and the composition of council of those First Nations, the committee heard the testimony of six witnesses during three meetings, but did not report the bill in the 2013-14 fiscal year. On February 27, 2014, the committee reported Bill C-16, An Act to give effect to the Governance Agreement with Sioux Valley Dakota Nation and to make consequential amendments to other Acts. Eight individuals gave testimony over the course of two meetings. The bill was reported without amendment.

The committee also received a government response, dated April 4, 2013, to the committee's report *Additions to Reserve: Expediting the Process*, which had been tabled in the Senate on November 1, 2012. The committee did not hear any witnesses on this order of reference.

Standing Committee on Banking, Trade and Commerce

A. **General Information**

During the 2013-2014 fiscal year, the committee considered three bills and the subject matter of one budget bill. It also engaged in three special studies.

As part of its general study regarding the present state of the domestic and international financial system, the committee had two appearances by the Governor of the Bank of Canada. At the request of the federal Minister of Finance, the committee undertook an examination of the ability of individuals to establish a registered disability savings plan (RDSP) with particular emphasis on legal representation and the ability of individuals to enter into a contract. In addition to written briefs, the committee heard from 16 witnesses, including the Minister of State (Finance), the Honourable Kevin Sorenson, P.C., M.P., and officials from the Department of Finance, disability advocacy groups, the legal community, financial institutions and businesses that provide financial planning services. Witnesses proposed various reasons for the low uptake rate in relation to the RDSP program, and offered suggestions on ways in which this rate might be increased. In March 2014, the committee tabled its report entitled *The Registered Disability Savings Plan Program: Why Isn't It Helping More People?*

In April and May 2013, the committee examined Bill S-17, An Act to implement conventions, protocols, agreements and a supplementary convention, concluded between Canada and Namibia, Serbia, Poland, Hong Kong, Luxembourg and Switzerland, for the avoidance of double taxation and the prevention of fiscal evasion with respect to taxes, and reported it without amendment. In May and June 2013, the committee examined Bill C-377, An Act to amend the Income Tax Act – requirements for labour organizations, and reported it without amendment but with observations. Also in June 2013, the committee examined Bill C-48, An Act to amend the Income Tax Act, the Excise Tax Act, the Federal-Provincial Fiscal Arrangements Act, the First Nations Goods and Services Tax Act and related legislation, and reported it without amendment but with observations.

Standing Committee on Conflict of Interest for Senators

A. General Information

The Standing Committee on Conflict of Interest for Senators was created under the *Rules of the Senate* to be responsible for all matters relating to the *Conflict of Interest Code for Senators* adopted in 2005, and to exercise general direction over the Senate Ethics Officer. An amended Code was adopted by the Senate in May 2008. On March 29, 2012, the committee presented a report to the Senate proposing six amendments to the Code. The report was adopted on May 1, 2012 and a revised Code came into force on October 1, 2012, including a key change – the posting of senators' public disclosure summaries on the Senate Ethics Officer's website.

The committee also presented a report on March 26, 2014, proposing amendments to the inquiry process under the Code.

The committee's responsibilities are detailed in the Code.

The membership of the committee is determined by a process that differs from that of all other committees. In accordance with the provisions of the Code, two members are elected by secret ballot in the respective caucuses of the government and opposition. A fifth member is then chosen by these four members. The chair of the committee must be chosen by at least four members of the committee.

Standing Committee on Fisheries and Oceans

A. General Information

Lobster is Canada's most lucrative fishery and remains an economic pillar for many communities in Atlantic Canada and Quebec. The industry is complex and the individuals, communities and companies that participate in the lobster value chain faced many challenges. In fiscal year 2013-2014, the committee studied the lobster fishery in Atlantic Canada and Quebec to better understand the structure of the industry; to follow-up on the 2009 committee report entitled *Crisis in the Lobster Fishery*; and to make recommendations to the federal government on the issues brought to the committee's attention. Witnesses included numerous stakeholders from Atlantic Canada and Quebec, government representatives, conservation experts and researchers. The committee issued its conclusions and recommendations in late May 2013.

In fiscal year 2013-2014, the committee studied Bill S-3, An Act to amend the Coastal Fisheries Protection Act, and reported it without amendment on December 4, 2013. On December 9, 2013, the Senate adopted a motion to request a complete and detailed response from the Government to the report entitled *The Lobster Fishery: Staying on Course*, with the Minister of Fisheries and Oceans identified as being responsible for the response. The same day, the Senate adopted a motion to request a complete and detailed response from the Government to the report entitled *The Sustainable Management of Grey Seal Populations: A Path Toward the Recovery of Cod and other Groundfish Stocks*. The Minister of Fisheries and Oceans was identified as the minister responsible, in consultation with the Minister of Health.

On December 9, 2013, the committee received an order of reference to examine the regulation of aquaculture, current challenges and future prospects for the industry in Canada. Hearings for this study began in January 2014, and a fact-finding mission and public hearings occurred in British Columbia in March 2014.

An order of reference authorizing the committee to examine issues relating to the federal government's current and evolving policy framework for managing Canada's fisheries and oceans was also received on December 9, 2013.

Standing Committee on Foreign Affairs and International Trade

A. General Information

In 2013-2014, the committee concluded its study of political and economic developments in the Republic of Turkey, which it had begun in the previous fiscal year. The committee's final report, entitled *Building Bridges: Canada-Turkey Relations and Beyond*, was tabled in the Senate on June 20, 2013. With the prorogation of the First Session of the Forty-First Parliament, on September 13, 2013, once the Second Session of the Forty-First Parliament was underway, the committee re-tabled the report on November 28, 2013. That report was adopted by the Senate with a request for a government response on February 27, 2014.

The bulk of the committee's work in the fiscal year focussed on its study of security conditions and economic developments in the Asia-Pacific region. The committee held extensive hearings, ultimately deciding to focus on four countries in the region: Indonesia, Myanmar (Burma), the Philippines and Singapore. The committee intends to travel to Indonesia and Singapore before completing the study.

In addition to its special study work, the committee examined one bill (Bill C-383, An Act to amend the International Boundary Waters Treaty Act and the International River Improvements Act), as well as studying the subject matter of those elements contained in Divisions 4 and 16 of Part 3 of Bill C-4, A second Act to implement certain provisions of the budget tabled in Parliament on March 21, 2013 and other measures.

Finally, the committee concluded its study of issues pertaining to the human rights of First Nations band members who reside off-reserve, tabling its final report, entitled *Recognising Rights: Strengthening Off-Reserve First Nations Communities*, on December 12, 2013.

In addition to these reports, the committee also held meetings in relation to Child Rights Impact Assessments, as well as the involvement of visible minority youth in the criminal justice system. The committee concluded the fiscal year by beginning a study of the implementation and operation of the Hague Abductions Convention.

Standing Committee on National Finance

A. General Information

The committee was first created in May 1919 as the Committee on Finance, and, in 1968, it was renamed the Committee on National Finance. The committee's work is focused on matters relating to government spending. As stated in the *Rules of the Senate* (Rule 12-7(5)), the committee has a mandate to examine matters related to federal estimates generally, including:

- i. the public accounts and the reports of the Auditor General; and
- ii. government finance.

The committee has historically been, and continues to be, one of the Senate's busiest committees. A large part of the committee's work is devoted to a review of the government's estimates and issues arising out of that review.

Study of the Estimates and Legislation

As is customary, much of the committee's attention was focussed on the estimates, which outline the Government's expenditure plans. The committee held meetings to examine various aspects of the Government's planned expenditures for 2013-2014 and 2014-2015, including the Main Estimates 2013-2014, Supplementary Estimates (A) 2013-2014, Supplementary Estimates (B) 2013-2014, and Supplementary Estimates (C) 2013-2014. The committee also undertook a preliminary examination of the Main Estimates 2014-2015 in March 2014, and tabled an interim report to the Senate. During these examinations, a range of issues were brought to the attention of the Senate by the committee.

Three bills were also reported by the committee:

- Bill C-60, An Act to implement certain provisions of the budget tabled in Parliament on March 21, 2013 and other measures, was reported without amendment;
- Bill S-217, An Act to amend the Financial Administration Act (borrowing of money), was reported with the recommendation that the bill not be proceeded with further in the Senate; and
- Bill C-4, A Second Act to implement certain provisions of the budget tabled in Parliament on March 21, 2013 and other measures, was reported without amendment.

With respect to Bill C-60 and Bill C-4, the committee undertook subject matter studies of the bills before they were introduced in the Senate. This allowed the committee to hear witnesses on the bills prior to their being read for the first time in the Senate. The committee tabled reports on each of the subject matter studies, providing a summary of the testimony heard during the pre-studies. When Bill C-60 and Bill C-4 were referred to the Standing Committee on National Finance, the committee proceeded directly to clause-by-clause consideration.

Two other bills were referred to the committee, but not reported prior to prorogation of the First Session of the 41st Parliament:

- Bill S-205, an Act to amend the Income Tax Act (carbon offset tax credit); and
- Bill S-211, An Act to amend the Official Languages Act (communications with and services to the public).

A. **General Information**

During the 2013-2014 fiscal year, the Standing Committee on National Security and Defence continued to hear witnesses on its general mandate to examine and report on Canada's national security and defence policies, practices, circumstances and capabilities.

In the spring of 2013, the committee completed its study on harassment in the Royal Canadian Mounted Police and tabled a report making 15 recommendations. In the fall of 2013, the committee heard witnesses as a follow-up to its reports on the Reserves, and on Arctic Sovereignty.

It conducted a fact-finding mission to Colorado Springs, United States, to gather information for this study.

The committee also commenced a study on the policies, practices, and collaborative efforts of Canada Border Services Agency in determining admissibility and inadmissibility into Canada.

Standing Committee on Official Languages

A. General Information

During 2013-2014, the Standing Committee on Official Languages simultaneously continued a number of studies that it began during the previous year. It concluded its hearings on CBC/Radio-Canada's obligations under the *Official Languages Act* and some aspects of the *Broadcasting Act* and adopted a final report, which was tabled on April 8, 2014.

The Senate renewed the committee's orders of reference to examine the best practices for language policies and second-language learning in a context of linguistic duality or plurality and the impacts of recent changes to the immigration system on official language minority communities. The committee held several meetings on each topic and considering that the subject matters overlap, on three occasions asked witnesses to address both subjects during their appearances.

Under the order of reference to study the application of the *Official Languages Act*, it invited the Minister of Canadian Heritage and Official Languages and the Commissioner of Official Languages to address the findings contained in their annual reports.

Finally, the committee was tasked to review Bill C-419, An Act respecting language skills. It held two meetings and reported the bill without amendment.

A. General Information

To begin the year, the Transport and Communications Committee completed its review of the Canadian airline industry with the tabling of its final report entitled *One Size Doesn't Fit All: The Future Growth and Competitiveness of Canadian Air Travel*. It then moved to a review of two pieces of legislation, Bill C-321, Canada Post Corporation Act – library materials, and Bill C-52, Canada Transportation Act.

During this time period, the committee also held one meeting on funding cuts to Radio-Canada International. After hearing from the leadership of the CBC, the committee reported to the Senate that it was satisfied with the explanations provided regarding the cuts in service. The committee also conducted another short study into the subject matter of Division 8 of Part 3 of Bill C-4 that authorizes the amalgamation of four Crown corporations that own or operate international bridges and gives the resulting corporation certain powers. It reported its support for the provisions in the bill to the Senate.

The vast majority of the committee's time was dedicated to a comprehensive review of the challenges faced by the Canadian Broadcasting Corporation relating to the changing broadcasting environment. It conducted a preliminary fact-finding mission to Western and Northern Canada to visit CBC and Radio-Canada installations and to meet with local stakeholders. The study will continue and a final report is anticipated before June 2015.
