Minimum of 122 credits total,</li> <li>2. 42 credits of 3000-level or higher coursework from a four-year institution,</li> <li>3. Grade of “C or better” in ENGL 2500 and grade of “C or better” in ENGL 1500 or ENGL 3020,</li> <li>4. Grade of “C or better” in at least 30 credits applied to Business Core and major,</li> <li>5. 50% of required business courses must be earned at Iowa State University,</li> <li>6. Last 32 credits applied to a degree must be taken at Iowa State University (exceptions for study abroad and internship may be requested),</li> <li>7. All 3000-level and higher business courses must be earned at a four-year college or university,</li> <li>8. Cumulative GPA of at least 2.0 with no Quality Point Deficiencies,</li> <li>9. Multiple business majors must have at least 15 distinct credits in each.</li> </ol>

**Notes Pertaining to the Curriculum:**

No courses taken for the business degree can be taken Pass-Not Pass (only non-business “free” electives may be taken P-NP).

Course prerequisites are monitored and will be enforced.
