**SUBJECT:** Fiscal Year 2023 Notices of Funding Opportunity

Today, the Federal Emergency Management Agency (FEMA), a component of the U.S. Department of Homeland Security (DHS), announced the availability of the Fiscal Year (FY) 2023 Notices of Funding Opportunity (NOFO) for eight grant programs. The funding notices released today represent \$2,000,100,000 in available FY 2023 federal assistance and may be found online at <http://www.fema.gov/grants> and at <http://www.grants.gov>.

NOFOs are available for the following programs:

- Homeland Security Grant Program (HSGP)
  - State Homeland Security Program (SHSP) - \$415,000,000
  - Urban Area Security Initiative (UASI) - \$615,000,000
  - Operation Stonegarden (OPSG) - \$90,000,000
- Tribal Homeland Security Grant Program (THSGP) - \$15,000,000
- Nonprofit Security Grant Program (NSGP) - \$305,000,000
- Transit Security Grant Program (TSGP) - \$93,000,000
- Intercity Passenger Rail – Amtrak (IPR) Program - \$10,000,000
- Intercity Bus Security Grant Program (IBSGP) - \$2,000,000
- Port Security Grant Program (PSGP) - \$100,000,000
- Emergency Management Performance Grant (EMPG) Program – \$355,100,000

Eligible applicants must apply for funding through the Grants.gov portal at <http://www.grants.gov>. When applicants apply through <http://www.grants.gov>, they must submit the Standard Form 424 in the initial Grants.gov application. The FEMA Non-Disaster (ND) Grants system will retrieve the Standard Form 424 directly from the Grants.gov system and will automatically populate the relevant data fields in the ND Grants application.

Applicants are strongly encouraged to begin the application process as soon as possible, including obtaining a Unique Entity Identifier (UEI) number. The UEI is a required application element and may take up to four weeks to obtain. Also, FEMA must conduct an initial eligibility review of the application prior to the final submission deadline. Therefore, **applicants are strongly encouraged to begin their initial application in Grants.gov at the time of this announcement** to ensure they have adequate time to start and complete their submission. Applicants should complete the initial Grants.gov application **no later than three days before the May 18, 2023, application deadline**. Upon the completion of the initial review, FEMA will determine whether an application is eligible to proceed further and will notify the applicant to complete their submission by fulfilling additional application requirements (e.g., Budget, Investment Justification, Work Plan) required for the relevant grant program. Initial applications are processed through the Grants.gov portal. Final applications are completed and submitted through FEMA's ND Grants System. Completed final applications for all grant programs must be submitted in ND Grants no later than **5 p.m. Eastern Time (ET), May 18, 2023**.

### **FY 2023 Homeland Security Grant Program (HSGP)**

HSGP includes a suite of risk-based grants to assist state, local, tribal and territorial efforts to prevent, prepare for, protect against, and respond to acts of terrorism. The grants included under HSGP are:

*State Homeland Security Program (SHSP)\**. In FY 2023, SHSP provides \$415 million to assist state, local, tribal, and territorial governments in preventing, preparing for, protecting against, and responding to acts of terrorism.

*Urban Area Security Initiative (UASI)\*.* In FY 2023, UASI provides \$615 million to assist high-risk urban areas in preventing, preparing for, protecting against, and responding to acts of terrorism.

*Operation Stonegarden (OPSG).* In FY 2023, OPSG provides \$90 million to support enhanced cooperation and coordination among state, local, tribal, territorial, and federal law enforcement agencies in a joint mission to secure the United States' borders along routes of ingress from international borders, to include travel corridors in states bordering Mexico and Canada, as well as states and territories with international water borders.

**FY 2023 Tribal Homeland Security Grant Program (THSGP)**

In FY 2023, THSGP provides \$15 million to directly eligible tribes to support the building, sustainment, and delivery of core capabilities to enable tribes to strengthen their capacity to prevent, prepare for, protect against, and respond to potential terrorist attacks. As in previous fiscal years, the THSGP will be a competitive grant program.

**FY 2023 Nonprofit Security Grant Program (NSGP)\***

In FY 2023, NSGP provides \$305 million in funding support for hardening and other physical security enhancements to nonprofit organizations that are at high risk of terrorist or other extremist attacks. Of this amount, \$152.5 million is available to nonprofit organizations located within one of the FY 2023 UASI-designated high-risk urban areas (NSGP-Urban Area or NSGP-UA). Additional, separate funding in the amount of \$152.5 million is also appropriated for nonprofit organizations located outside of the FY 2023 UASI-designated urban areas (NSGP-State or NSGP-S\*). As in previous fiscal years, the NSGP will be a competitive grant program.

**FY 2023 Transit Security Grant Program (TSGP)**

In FY 2023, TSGP provides \$93 million to support transportation infrastructure security activities. The TSGP provides funds to eligible public transportation systems (which include intra-city bus, commuter bus, ferries, and all forms of passenger rail) that serve historically eligible UASI-designated urban areas to protect critical surface transportation infrastructure and the traveling public from acts of terrorism and to increase the resilience of transit infrastructure. As in previous fiscal years, the TSGP will be a competitive grant program.

**FY 2023 Intercity Passenger Rail (IPR) – Amtrak Program**

In FY 2023, IPR provides \$10 million to the National Passenger Railroad Corporation (Amtrak) to protect critical surface transportation infrastructure and the traveling public from acts of terrorism and to increase the resilience of the Amtrak rail system.

**FY 2023 Intercity Bus Security Grant Program (IBSGP)**

In FY 2023, IBSGP provides \$2 million to owners and operators of intercity bus systems providing services to historically eligible UASI-designated urban areas, to protect critical surface transportation infrastructure and the traveling public from acts of terrorism and to increase the resilience of transit infrastructure. As in previous fiscal years, the IBSGP will be a competitive grant program.

**FY 2023 Port Security Grant Program (PSGP)**

In FY 2023, PSGP provides \$100 million to provide funds to port authorities, facility operators, and state, local, and territorial agencies required to provide security services to implement Area Maritime Security Plans, facility security plans, and other port-wide risk management activities. As in previous fiscal years, the PSGP will be a competitive grant program.

**FY 2023 Emergency Management Performance Grant (EMPG) Program\***

In FY 2023, the EMPG Program provides \$355 million to assist state, local, tribal, and territorial governments in preparing for all hazards. In addition to this funding, FEMA must also make available \$100,000 from the Disaster Relief Fund to the Federated States of Micronesia and the Republic of the Marshall Islands pursuant to Article X of the Federal Programs and Services Agreement of the *Compact of Free Association Amendments Act of 2003*, Pub. L. No. 108-188.
