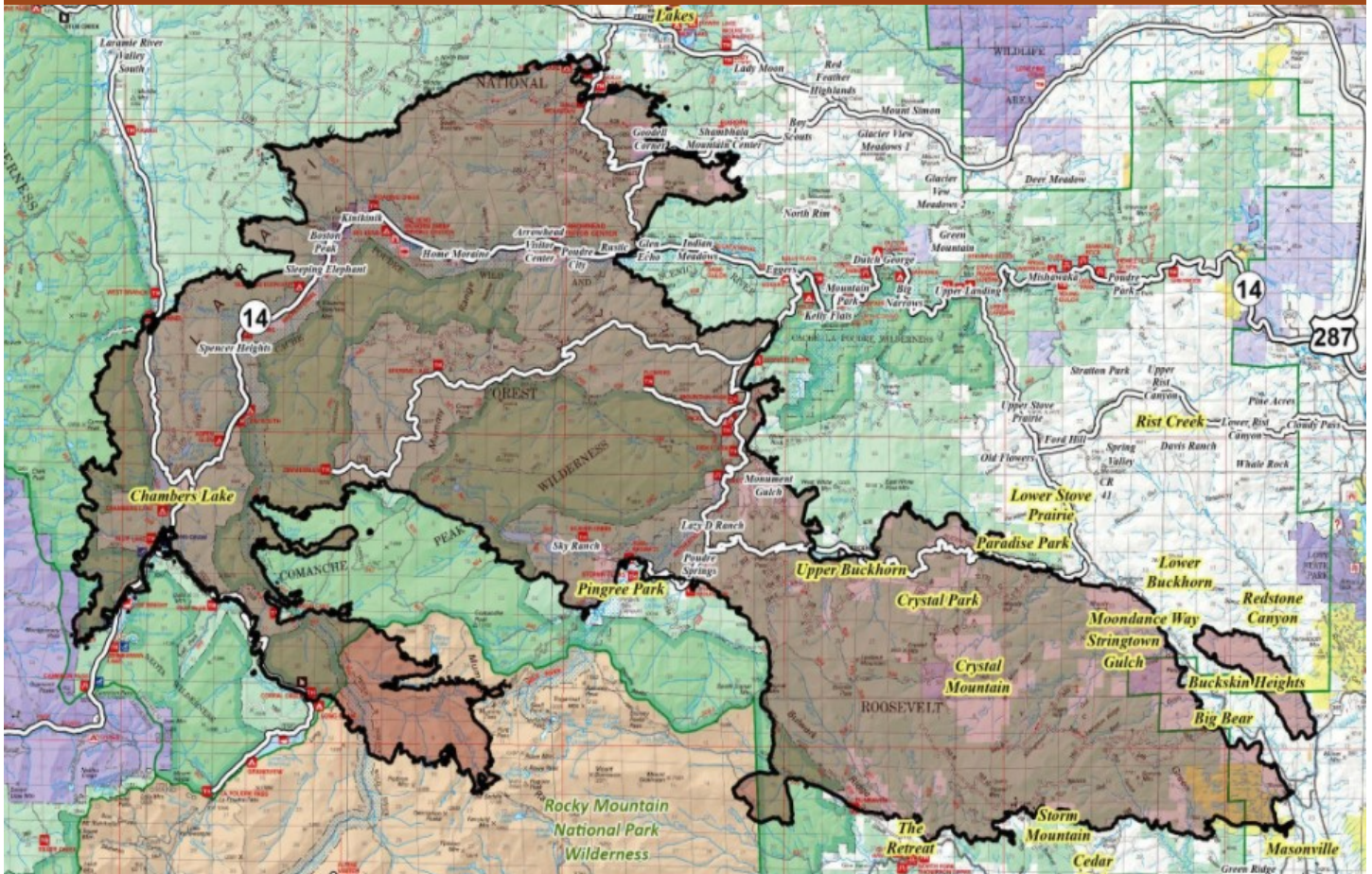

Spring and Summer Activities

Multiple efforts will begin in the Fire Area starting at the end of April. In the next few pages, we will provide information about these activities, provide resources and discuss timelines.



Activities outlined in this newsletter include the following recovery/restoration actions:

- Suppression Repairs for handline and dozer lines. Property owners in these areas have already been notified and have provided consent for the work.
- Sandbagging Efforts—Serve 6.8 in partnership with Larimer County, will be pre-staging sandbags throughout the fire area and to downstream communities for flood risk.
- Seed, wattle and mulching opportunities for erosion control efforts
- Debris Removal and Community Clean-up Days—Dumpsters will be available throughout the fire area for community members to use for clean-up. Volunteers are being recruited now for community clean-up weekends.
- Vegetative Debris Removal—Staging location will be set for vegetative debris to be mulched and used in the fire area.

Timeline of Recovery / Restoration Activities



MAY 2021

May 1st: Dumpsters will be available for community member use (primary and secondary landowners)

May 1-30: Tree removal and mulching operations along roadways and streams

May 1-June 1: Sandbags will be pre-positioned throughout the fire area (see enclosed map)



JULY 2021

June – July: Community clean-up operations and erosion control efforts with volunteer groups

June – July: Emergency Watershed Protection measures implemented including private/public land erosion control, property protection, public road/culvert armoring.



SEPTEMBER 2021

APRIL 2021

April 19-30: Debris Contractor will be conducting site assessments in the fire area.

April 19-30: Arborist will be assessing and tagging trees along select private and public roads for hazardous tree removal.



JUNE 2021

June – July: Community clean-up operations and erosion control efforts with volunteer groups

June – July: Emergency Watershed Protection measures implemented including private/public land erosion control, property protection, public road armoring and public culvert repairs.



AUGUST 2021

August – September: Larimer County Road & Bridge and Engineering upsizing county-owned culverts in the fire area.

September and Beyond: Planning for 2022

Right-of-Entry Permissions

In order to do any work on private lands, permissions will need to be granted by property owners. Larimer County has partnered with the Watershed Coalitions, municipal partners and volunteer / Non-profit organizations to create one Right-of-Entry Form that can be signed by property owners for recovery and restoration projects. This is for both primary and secondary properties.

Weed Management

To help residents affected by the Cameron Peak Fire, the Larimer County Weed District will be conducting free weed management site visits this summer. Weeds are often invigorated by fire leading to a much slower recovery, if left unchecked. Staff can help assess the condition of the vegetation community and create a site-specific weed management plan that will benefit the environment, saving the resident time and money. Seed / Mulch Resources

The Big Thompson Watershed Coalition and the Coalition for the Poudre River Watershed are working collaboratively with volunteer groups and Larimer County to provide limited seed, mulch and wattles for community members and community projects as well as resources for how community members can purchase additional supplies.

Educational programs will be available through the watersheds regarding the proper placement of erosion control materials, proper seeding and mulching, and other actions that can be taken to minimize flood and debris impacts. More information will be provided soon on these supplies and programs.

The Larimer County Weed District is also partnering with the Colorado Water Conservation Board, AloTerra Restoration Services, and the Cameron Peak Recovery Collaborative to create native seed mixes that can restore ecosystem function, discourage weed invasion and stabilize soils with a diversity of grasses and wildflowers. These upland seed mix specifications will be broken out by elevation and are available for purchase from local seed distributors.

Debris Removal Efforts

Debris Programs to Assist Community Members include: Streamway Debris Removal, Right of Way Debris Removal and Hazardous Tree Removal.

- Streamway Debris Removal—Removing loose vegetative debris from the streams and rivers to decrease the chances of debris causing dams along culverts and bridges.
- Right of Way Debris Removal—Removing debris from county roads and county right of ways. This includes hazardous trees and woody debris that can cause a hazard. The county is also setting up vegetative debris staging locations for private debris.
- Hazardous Tree Removal – Post-wildfire, many burned trees become a significant hazard for falling, creating a danger to people on trails or roads. Larimer County plans to conduct debris removal efforts to remove these tree hazards.



Property Clean-Up

Larimer County will be providing dumpsters throughout the fire area for household debris clean-up efforts. These dumpsters and scrap metal bins will be available from May 1st through July 31st for both primary and secondary homes. A map will be provided as soon as the locations have been finalized.

The Larimer County Long-Term Recovery Group, a volunteer organization, is recruiting volunteer teams now to be ready to assist community members with community clean-up efforts. These teams will be mobilized in June and July.

NOCO Alert

- Imminent threats only!
- Evacuation orders
- Requires registration (FREE)

National Weather Service

- Sign up at NOCO Alert
- Generic location impact
- Seek out more information

Wireless Emergency Alerts

- Location specific
- May reach outside impact area
- Not all phones will receive message

FLOOD2021

- Text message only
- No registration needed
- Emergency & Non-emergency updates

WEATHER RADIOS

Weather alert radios with back up battery power or emergency crank operate without electricity. As long as you have extra batteries or can turn the crank, a weather radio will broadcast severe weather and emergency alerts sent to NWR from federal, local and state authorities.

SBA Assistance Programs

The **Small Business Administration** has programs available to those needing assistance.

- SBA Disaster Loans for Physical Damages. Deadline April 26, 2021
- SBA Working Capital Loans Due to Drought—These low-interest loans are to offset economic losses because of reduced revenues caused by drought (could assist rafting companies, fishing, outdoors activities, etc.). Deadline to apply is May 11, 2021
- SBA Disaster Loans for Economic Impacts. No deadline has been set but it is expected that people may be able to apply through August.

Rural Home Loans Program—USDA

What does this program do?

Also known as the Section 502 Direct Loan Program, this program assists low- and very-low-income applicants obtain decent, safe, and sanitary housing in eligible rural areas by providing payment assistance to increase an applicant's repayment ability. Payment assistance is a type of subsidy that reduces the mortgage payment for a short time. The amount of assistance is determined by the adjusted family income.

Who may apply for this program?

A number of factors are considered when determining an applicant's eligibility for Single Family Direct Home Loans. At a minimum, applicants interested in obtaining a direct loan must have an adjusted income that is at or below the applicable low-income limit for the area where they wish to buy a house and they must demonstrate a willingness and ability to repay debt. This is for primary residences only.
